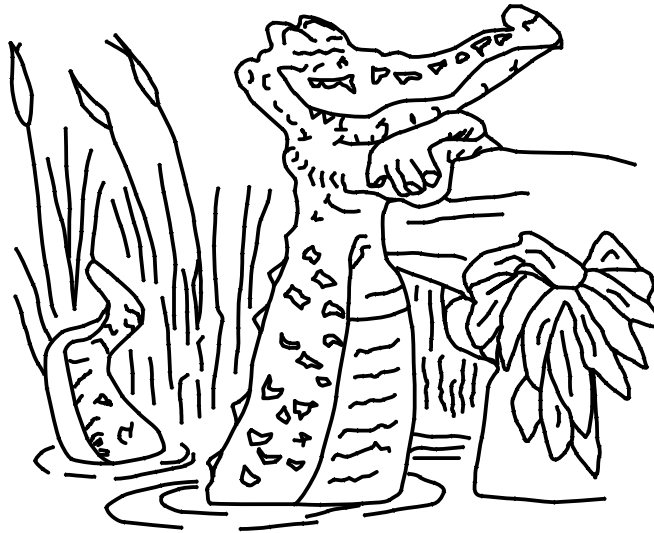

Council has received a letter from M Marquis express concern as to why they were prevented from camping on the banks of the Gregory River at Gregory. Cr Tracy Forshaw has also advised that she has been told that there is “a gentleman in town abusing our tourists about camping on the river – down near the bridge.” That same gentleman “came along and took all the bins and put them up at the park area”. Cr Forshaw has further advised that tourists were “under the impression it was a Council person telling them they were not allowed to camp in the river”.

  - a) That Council is deeply concerned that there appears to be a person harassing tourists to the region seeking to stay at Gregory;
  - b) That Council has no officers instructing tourists to move from the Gregory River;
  - c) That any person purporting to have authority to move tourists from such area should be asked to produce their identification and cite their authority to issue instructions and, if they are unable to do so, the matter should be referred to the Local Police for their attention;
  - d) That, while Council’s preference is that campers do not camp in the river bed (As indicated in the signage in the area), Council has no intention of undertaking any enforcement actions at this time and Council currently has no powers to do so; and
  - e) Council’s preference is that campers stay in approved Camping areas however there are no such approved camping areas in Gregory at this time because:
    - a) Council is unable to obtain appropriate tenure over its preferred camping area; and
    - b) No business in the town has obtained any town planning approval at this time to run a caravan park or camping area.
- 2) That the Queensland Police be asked to investigate the matter of a person
  - a) seeking to act with an unidentified authority to move people on in the township of Gregory; and

An application has been received from Mr Ken Booth on behalf of Mungabayi Business Association Pty Ltd for Council approval to put up a sign advertising their business at approximately .895kms south of Burketown on the Floraville Road. The sign is 2.4m x 1.2m in size.

- a) The location of the placement of the sign being agreed to by Council's Director Engineering Services having regard to Council's maintenance requirements on its roads and traffic safety issues;

  - a) Location – Lateral Placement – The sign should be located so that a Clear zone is maintained between the sign and the edge of the bitumen road of at least 9 metres;
  - b) Location - The sign should not be placed on a curve;
  - c) Indemnity - The applicant will need to indemnify, and keep indemnified, Council against all actions, proceedings, claims, demands, costs, losses, damages and expenses that may be brought against Council which arise as a result of the installation of the sign including any trimming /clearing of vegetation undertaken to install the sign;
  - d) Insurance – The applicant will be required to provide Council with evidence of public liability insurance of not less than \$10M for the sign including confirmation that Council is listed on the policy as a co-insured with respect to such sign. The applicant will need to ensure that such insurance cover is maintained whilst the sign remains installed on the road;
  - e) The applicant will need to acknowledge the right of Council to direct the removal of the sign at any time and applicant will need to acknowledge and accept the responsibility for the costs of such removal by Council in the event that the applicant does not enact the removal within 30 days of being requested to do so by Council.

Correspondence has been received from the Department of Environment and Resource Management with respect to three blocks of ground in Gregory that are of interest to the Waanyi People. Council views are sought.

That the Department be advised as follows:-

a) With respect to Lot 1 on AP13658 the existing town plan and the strategic town plan is at odds with the current use. This is because Council is hoping to have the industrial activities relocated to the North eastern part of the community adjacent to the highway. It is connected to water. It would be retrograde for the existing permit to occupy over this block for the current pre-existing non-conforming use to be cancelled when there is no land currently available in Gregory for such industrial uses to relocate to. Until such time as alternative industrial use land is available in the town of Gregory this permit to occupy should be retained. Transfer of tenancy under the Aboriginal Land Act should not occur at this time.

b) With respect to Lot 11 on AP13658 the existing town plan and the strategic town plan are seeking this land to be Community/Recreational. Given the existing adjacent subdivision it would not seem that this block lends itself to housing development at this time however it does lend itself to the Community/Recreational use proposed under the town plan. Any transfer of tenancy under the Aboriginal Land Act should be restricted to conforming uses under the existing town plan.

c) With respect to Lot 17 on AP11667 Council's existing application to utilise this area for recreational purposes should already adequately describe Council's intent for this land. Transfer of tenancy under the Aboriginal Land Act should not occur and Council's application should take precedence.
